"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Austin Township,

on the northwestern side of Bethel Road, being shown as the western half of the property on plat made by C. O. Riddle, April 23, 1969, recorded in Volume 4B at page 43, and having according to said plat the following metes and bounds, to-wit:

BEGINNING at an iron pin in the center of Bethel Road at the joint corner of other property of C. S. Verdin, Jr. and running thence with line of said property, N 39-10 W 209 feet to an iron pin; thence N 52-40 E 104.5 feet to pin; thence S 39-10 E 209 feet to pin in center of Bethel Road; thence with center of Bethel Road is a line S 52-40 W 104.5 feet to the point of beginning.
