WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortage, or any singulations set out in this mortages, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagor for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagee to the Mortgagor's account, and also in consideration of the sum of Three Dollars (3500) to the Mortgagor in hand well and truly paid by the Mortgagor and before the scaling of these presents, the receipt whereof is hereby ocknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagor, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improximents thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 102 of a subdivision known as Coleman Heights according to a plat thereof prepared by Terry T. Dill, Surveyor, February 1958, recorded in the R. M. C. Office for Greenville County in Plat Book RR at Page 115 and having the following metes and bounds, to-wit:

BEGINNING at an iron pin on the western side of West Drive, joint front corner of Lots 101 and 102 and running thence with the joint line of said lots, S. 66-35 W. 279.7 feet to an iron pin; thence with the rear line of Lot 102, S. 17-01 E. 149.8 feet to an iron pin at the joint rear corner of Lots 102 and 107; thence with the joint line of said lots, N. 66-43 E. 277.8 feet to an iron pin on the western side of West Drive; thence with the western side of West Drive; thence with the western side of West Drive, N. 16-17 W. 150.4 feet to the point of beginning; being the same conveyed to me by Stanley I. Coleman by deed dated March 17, 1969 and recorded in the R.M.C. Office for Greenville County in Deed Vol. 864 at Page 107;
