

MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

I, Calvin M. Thompson, of Greenville County

.. (hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Morigagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

Twenty-Seven Thousand, Five Hundred and No/100-----(\$.27,500,00) Dollars, as evidenced by Mortgagor's promissory note of even date herewith, said note to be repaid with interest at the rate

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any gly-Laws or the Charter of the Marigagee, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to scrute same, for the purpose of collecting said principal, due, and interest, with costs and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dalars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Greenville Township, on the south side of Henrietta Street, and having, according to plat thereof entitled Property of Franklin Real Estate and Investment Company made by Dalton & Neves, Engineers, November 1930, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the south side of Henrietta Street, 594.7 feet east of the southeastern intersection of Henrictta Street and McGee Street, and running thence with the south side of Henrictta Street, S. 89-55 E. 65 feet to an iron pin; thence S. 00-28 W. 123.8 feet to an iron pin; thence S. 81-00 W. 65 feet to an iron pin; thence N. 00-05 E. 134 feet to an iron pin on the south side of Henrictta Street, the beginning corner; being the same conveyed to me by Walter Λ. Chandler, Jr. by deed dated June 20, 1969 to be recorded herewith."
