"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 20 of a subdivision entitled "Final Plat Section C-1 Gower Estates", prepared by R. K. Campbell & Webb Surveying and Mapping Company, July 27, 1963, and recorded in the R. M. C. Office for Greenville County in Plat Book YY at Page 112, and having, according to said plat, the following metes and bounds, to-wif:

"BEGINNING at an iron pin on the eastern side of Ponderosa Road at the joint front corner of Lots Nos. 19 and 20 and running thence with the joint line of said lots, S. 68-45 E. 185 feet crossing a creek to an iron pin; running thence with the rear line of Lot No. 20, N. 20-30 E. 156.7 feet crossing said creek to an iron pin at the joint rear corner of Lots Nos. 20 and 21; thence with the joint line of said lots, N. 74-04 W. 209 feet to an iron pin on the eastern side of Ponderosa Road, joint front corner of Lots Nos. 20 and 21; running thence with the eastern side of said Ponderosa Road S. 10-18 W. 110 feet to an iron pin; thence continuing with the eastern side of said Ponderosa Road, S. 12-57 W. 29.6 feet to the point of beginning.
