WHEREAS, the Mortgagor may hereafter become indebted to the sald Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesald debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indicated to the Mortgagor at any time for advances made to or for his account by the Mortgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly pald by the Mortgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns:

"All that certain plece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Lot No. 1 on plat of Capitol City, Real Estate made by J. C. Hill, LS, November 23, 1959 and recorded in Plat Book 00, Page 377 in the RMC Office for Greenville County. According to said plat the property is more fully described as follows:

Beginning at an iron pin at the intersection of Ghana Drive and Blassengame Road and running thence with said Blassengame Road M: 23-15 E: 78 feet to an iron pin; thence continuing with said road M: 32 E: 41 feet to an iron pin; thence continuing with said road M: 46 E: 38.3 feet to an iron pin; thence leaving said road and running S 70-10 E: 52.8 feet to an iron pin at the joint rear corners of Lots 1 and 2; thence with the joint line of said lots S 25-15 W: 150 feet to an iron pin on Ghana Drive; thence N 74 W: 60 feet to an iron pin at the point of beginning.
