"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Caroline, County of Greenville, Fairview Township, containing 1.31 acres, according to a plat prepared by C. O. Riddle, Surveyor, June 13, 1969, said plat entitled, "Property of Edna S. Green near Fountain Inn, S. C.", and having the following metes and bounds, according to said plat, to-wit: BEGINNING at an iron pin in the Western edge of an unnamed Street or Road, joint corner with lands of the Mortgagee, and running thence with the Western edge of said Street or Road S. 23-32 W. 225.4 feet to an old iron pin and stone, joint corner with land, now or formerly, of J.
