"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and heing in the State of South Carolina, County of Greenville, and being on the western side of Heathwood Drive near the City of Greenville, and known and designated as Lot No. 75 of a subdivision known as Heathwood, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book KK at Page 35, and according to said plat has the following metes and bounds, to wit:

BEGINNING at an iron pin on the western side of Heathwood Drive at the joint front corner of Lots Nos. 74 and 75 and running thence with the joint line of said Lots S. 37-12 W. 201.7 feet to an iron pin, running thence S. 45-20 E. 125 feet to an iron pin at the joint rear corner of Lots Nos 75 and 76, running thence with the joint line of said Lots N. 44-40 E. 200 feet to an iron pin on the western side of Heathwood Drive, running thence with the western side of said Drive N. 39-39 W. 98.8 feet to an iron pin, point of beginning.
