NOW, KNOW ALL MEN, That the Martgagor, in consideration of the aforesaid dobt, and in order to secure the payment thereof, and of any other further sums for which the Martgagor may be indebted to the Martgagoe and sin any time for advances made to a for his account by the Martgagoe, and also in consideration of the further sum of Three Dollars (\$3.00) to the Martgagoe in hand well and truly paid by the Martgagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Martgagoe, its successors and assigns:

All that lot of land in the county of Greenville, state of South Carolina, on the west side of White Horse Road, containing .34 acres more or less, designated as tract "B" on plat thereof made by J. R. McClure, R.L.S., July 26, 1969 and having according to said plat the following metes and bounds, courses and distances, to-wit:

Beginning at an iron pin on the west side of White Horse Road, corner of property this day sold to D. B. Cox & Fitzhugh Lee Saunders; thence with the line of said property S. 76-59 W. 155.44 feet to an iron pin; thence turning N. 12-10 E. 136.4 feet to an iron pin corner of property of the grantor; thence with the line of said property N. 74-11 E. 88.52 feet to an iron pin on the west side of White Horse Road; thence with the west side of said Road S. 14-36 E. 128.14 feet to the beginning corner.

This mortgage is given to secure a portion of the purchase price of the within described property.

Together with all and singular rights, members, hereditaments, and appurtenances to the same belonging in any way incident or appertaining, and of all the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is lawfully solzed of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumber the same, and that the premises are free and clear of all flens and encumbrances except as provided herein. The Mortgagor further covenants to warrant and forever defend all and singular the said premises unto the Mortgagoe forever, from and against the Mortgagor and all persons whomsoever lawfully claiming the same or any part thereof.

The Mortgagor further covenants and agrees as follows:

- (1) That this mortgage shall secure the Mortgagee for such further sums as may be advanced hereafter, at the option of the Mortgagee, for the payment of taxes, insurance premiums, public assessments, repairs or other purposes pursuant to the covenants herein. This mortgage shall also secure the Mortgagee for any further loans, advances, readvances or reddis that may be made hereafter to the Mortgager by the Mortgagee so long as the total indebtedness thus secured does not exceed the original amount shown on the face hereof. All sums so advanced shall bear interest at the same rate as the mortgage debt and shall be payable on demand of the Mortgagee unless otherwise provided in writing.
- (2) That it will keep the improvements now existing or hereafter erected on the mortgaged property insured as may be required from time to time by the Mortgagee against loss by fire and any other hazards specified by Mortgagee, in an amount not less than the mortgage debt, or in such amounts as may be required by the Mortgagee, and in companies acceptable to it, and that all such policies and renewals thereof shall be held by the Mortgagee, and that extended thereto loss payable clauses in favor of, and in form acceptable to the Mortgagee, and that it will pay all premiums used in the use of the proceeds of any policy insuring the mortgaged premises and does hereby authorize each insurance company concerned to make payment for a loss directly to the Mortgage, to the extent of the balance owing on the Mortgage debt, whether due or not.
