surficient policy to take the place of the one so expiring shall be delivered to the mortgage all moneys recoverable under each such policy, and agrees that in the event of a loss the amount collected under any policy of insurance on said property may at the option of the mortgages, be applied by the mortgage upon an incheited and/or obligation secured hereby and in such order as mortgages may determine, or said amount or any portion thereof may, at the option of the mortgages, either be used in replacing, repairing or restoring the improvements partially or totally destroyed to a condition satisfactory to still mortgages, or be released to the mortgager all the mortgages that be mortgaged and independent of the mortgage shall be amount so released or used be deemed a payment on any indebtodness secured hereby.
