......(hereinafter referred to as Mortgagor) SEND(S) GREETINGS;

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

THREE THOUSAND

(\$ 3,000.00)

Dollars, as evidenced by Mortgagor's promissory note of even date herewith, said note to be repaid with Interest at the rate

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be part due and unpaid for a period of thirty days, or if there shall be any failure to comply with and adide by any By-Laws or the Charter of the Mortgage, or any stipulations set out in this mortgage, the whole anount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure some, for the purpose of collecting said principal due, and interest, with costs and expenses for such precedings, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said dabt and to secure the payment thereof and any further sums which may be advanced by the Mortgage to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly part by the Mortgage and and before the seeiling of these presents, the receipt whereof is bereby acknowledged, has granted, bargained, sold, and released, and by these presents does greatly bargain, self and release unto the Mortgagee, its successors and assigns, the following described estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be reastructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, near the city of Greenville, on the southwest side of Gallon Street, and having the following metes and bounds, to-wit:

Beginning at an iron pin on the southwest side of Gallon Street, joint front corner of property of grantor and Carol E. Vaughn, and running thence with the joint line of said property S. 60-50 W. 67 feet to a point in the center of Brushy Creek; thence with the center of the creek as the line N. 17-54 W. 68 feet to a point in the center of said creek in line of Allen E. Vaughn property; thence with the line of said property N. 60-50 E. 79 feet to an iron pin on the southwest side of Gallon Street; thence with the southwest side of said street S. 28-17 E. 67 feet to the point of beginning.
