WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpaid for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgage, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagoe to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagoe and before the sealing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, patrel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown as Lot 2, Section Five of Richmond Hills, plat of which is recorded in the R. M. C. Office for Greenville County in Plat Book WWW at Page 38, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Konnarock Circle, joint front corner of Lots Nos. 1 and 2, and running thence along the joint line of said lots, S. 28-34 W. 150.0 feet to an iron pin on the line of property now or formerly of Pearle J. Ross; thence along the line of that property, N. 61-26 W. 100.0 feet to an iron pin at the rear corner of Lot No. 3; thence along the line of that lot, N. 28-34 E. 150.0 feet to an iron pin on the southwestern side of Konnarock Circle; thence along the southwestern side of Konnarock Circle, S. 61-26 E. 100.0 feet to the beginning corner; being the same conveyed to me by Williams Builders, Inc. by deed dated August 4, 1969, to be recorded herewith.
