MORTGAGE OF REAL ESTATE

COUNTY OF GREENVILLE

To All Whom These Presents May Concern:

L. John C. Williams, of Greenville County,

(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mertgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

Sixteen Thousand, Five Hundred Fifty and No/100-----(\$.16,550.00) Dollars, as evidenced by Mortgagor's promissory note of even date herewith, said note to be repaid with interest at the rate

therein specified in installments of One Hundred Twenty-Seven and 74/100 (\$ 127.74 ).

Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable. 20. years after date; and

WHEREAS, sald note further provides that if at any time any portion of the principal or interest due thereunder shall be past due and unpair for a period of thirty days, or if there shall be any failure to comply with and abide by any By-Laws or the Charter of the Mortgage, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any cultaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagee for such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any future sums which may be advanced by the Mortgage to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$300) to the Mortgagor in hand well and tutyl paid by the Mortgage and before the seculing of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements, thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 264, Section 6, Sheet One, of a subdivision known as Colonial Hills as shown on a plat thereof prepared by Picdmont Engineers & Architects, dated March 21, 1966, recorded in the R. M. C. Office for Greenville County in Plat Book WWW, at Page 12, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Creighton Street, joint front corner of Lots 263 and 264, and running thence along the joint line of said lots, S. 16-35 E. 165.0 feet to an iron pin at the joint corner of Lots 263, 264 and 265; thence along the line of Lots 265, N. 73-25 E. 108.7 feet to the turnaround of Creighton Court; thence following the curvature of Creighton Court, the chord of which is N. 4-45 W. 30.55 feet, to an iron pin; thence continuing along the western side of Creighton Court, N. 16-35 W. 110.0 feet to an iron pin; thence along the intersection of Creighton Court and Creighton Street, N. 61-35 W. 35.4 feet to an iron pin on the southern side of Creighton Street, S. 73-25 W. 90.0 feet to the beginning corner; being the same conveyed to me by Williams Land Company, Inc. by deed dated August 7, 1969, to be recorded herewith.

The mortgagor's promissory note referred to above, contains, among other things, a provision for an increase in the interest rate,
