TOGETHER with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or apportaining, including all heating, plumbing and electrical fixtures, and any other equipment or fixtures now or hereafter attached, connected or fitted in any manner, it being the intention of the parties hereto that all such fixtures and equipment, other than household furniture, be considered a part of the realty.

TO HAVE AND TO HOLD all and singular the said premises unto the Mortgagee, its successors and assigns forever.

That Mortgogor will keep the improvements on the mortgaged premises, whether now existing or hereafter to be erected, insured against loss by fire, windstorm and other hazards in a sum not less than the balance due hereunder at any time and in a company or companies acceptable to the Mortgagee, and Mortgagor does hereby assign the policy or policies of insurance to the Mortgagee and agrees that all such policies shall be held by the Mortgagee and shall include loss payable clauses in favor of the Mortgage; and in the event of loss, Mortgagor will give immediale notice thereof the Mortgage by registered mail; and should the Mortgage at any time fall to keep said premises insured or fall to pay the premiums for such insurance, then the Mortgagee may cause such improvements to be insured, in the name of the Mortgagor and reimburse itself for the cost of such insurance, with interest as hereimshowe provided.
- 4. That the Mortgagor will keep all improvements upon the mortgaged premises in good repair, and should Mortgagor fail to do so, the Mortgagoe may, at its option, enter upon said premises and make whatever repairs are necessary and charge the expenses for such repairs to the mortgage debt and collect the same under this mortgage, with interest as hereinabove provided.
