"ALL that certain piece, parcel or lot of land, with all haproxements thereon, or breather constructed thereon, situate, lying and baing in the State of South Carolina, County of Greenville, being known and designated as Lot No. 3 of a Subdivision of property of J. K. Keller, as shown on plat thereof, prepared by C.O. Riddle, R.L.S., September, 1963, and recorded in the R.M.C. Office for Greenville County, in Plat Book EEE, at page 77, and having, according to said plat, the following metes and bounds, to-wit:
