WHEREAS, the mortgaged property described above has been conveyed and is presently owned by Katherine D. Dillard , hereinafter referred to as the "Obligor", who as a part of the consideration of the purchase of hereinafter resaid property have assumed and agreed to pay the balance due to the Travelers Rest Federal loan referred to above, and

WHEREAS, the Obligor is delinquent in making his mortgage payments in accordance with the terms and conditions of said note and mortgage, which delinquency through the month of July , 1969 amounts to the sum of \$ 326.82 , plus \$ attorney fees, making a total of \$ 326.82 , and

NOW, THEREFORE, after payment by the Obligor totaling § 326.82 as referred to above, the current mortgage believe amounts to § 12,721.95 together with interest on said amount as of July 1, 10 69 at the rate of Six and One-half (6%) per centum per annum; and it is hereby agreed by the undersigned to the undersigned t parties that the interest rate on said balance is hereby changed to Eight (8) per centum per annum from July, . 19 69 forward.

It is FUTHER AGREED that said mortgage balance shall be paid at the rate of $\frac{104.81}{104.81}$ per month, beginning $\frac{\text{August 3}}{\text{Elaht}}$, with payments applied first to interest at the rate of $\frac{Elaht}{\text{Elaht}}$ (8) per centum per annum and then to the remaining principal balance due from month to month. It is agreed that with the exception of the change in interest rate and monthly payments, that all other terms and conditions of the note and mortgage shall remain unaffected.

This Agreement shall bind jointly and severally the heirs, executors, administrators, successors, and assigns of the Association and the Obligor, respectively.
