TOGETHER with all and singular the Rights, Members, Hereditaments, and Appurtenances to the said Premises belong, or in anywise incident or appertaining.

AND IT IS COVENANTED AND AGREED by and between the parties hereto that all gas and electric fixtures, radiators, heaters, engines and machinery, bollers, ranges, elevators, and motors, bath-tubs, sinks, water-closets, basins, pipes, faucets and other plumbing and heating fixtures, mirrors, mantels, refrigerating plant and ice-boxes, cooking apparatus and appurtenances, and such other goods and chattels and personal property are furnished by a landdord in letting or operating an unfurnished building, similar to the one herein described and referred to, which are or shall be attached to said building by nails, screws, bolts, pipe connections, masonry or in any other manner, are and shall be deemed to be fixtures and an accession to the freehold and a part of the really as between the parties hereto, their heirs, executors, administrators, successors and assigns, and all persons claiming by, through or under them, and shall be deemed to be a portion of the security for the indebtedness herein mentioned and to be covered by this mortgage.

The mortgagor agrees to pay all taxes, assessments, water rates and other governmental or municipal charges which may constitute a charge upon the above described premises and, at the option of the mortgages, to deliver the official receipts therefor to the mortgages, and in default of said payments, the mortgage may pay the same and add the amount thereof to the debt secured by this mortgage.

As required by the mortgage, the mortgage agrees that there shall be added to each monthly payment required hereunder or under the evidence of debt secured hereby, an amount estimated by the Mortgages to be sufficient to enable the Mortgages to pay as they become due, all tases, assessments, hazard insurance premiums, and similar charge upon the permits subject thereto; any defliciency because of the insufficiency of such additional payments shall be forthwith deposited by the Mortgage own the premit Mortgage on the mortgage of the Mortgage or with the assessments, hazard insurance premiums or similar charges hereunder.

The mortgagor agrees that he will keep the premises in as good order and condition as they are now and will not comunit or permit any waste thereof, reasonable wear and tear excepted.

And the said mortgagor agree 5 to insure and keep insured the houses and buildings on said lot in a sum not less than Thirteen Thousand Three Hundred Fifty Dollars in a company or companies Hundred Fifty to the mortgages from loss or damage by fire, and the sum of Thirteen Thousand Three

Dollars from loss or damage by tomado, or such other casualties or contingencies (including war damage), as may be required by the mortgagee and assign and deliver the policies of insurance to the said mortgagee, and that in the event the mortgager... shall at any time fail to do so, then the mortgage may cause the same to be insured and relimbures itself for the premium, with interest, under this mortgage; or the mortgage at its election may on such failure declare the debt due and institute foreclosure proceedings.

AND should the mortgages, by reason of any such insurance against loss or damage by fire or tornado, or by other casualties or contingencies, as aforesaid, receive any sum or sums of money for any damage by fire or tornado or by other exaustices or contingencies, to the said building or buildings, such amount may be retained and applied by it toward payment of the amount hereby secured; or the same may be paid over, either wholly or in part, to the

sald mortgagor. Its successors, heirs or assigns, to enable such parties to repair said buildings or to erect new buildings in their place, or for any other purpose or object satisfactory to the mortgagee, without affecting the lien of this mortgage for the full smount secured thereby before such damage by fire or tornado, or by other casualties or contingencies, or such payment over, took place.
