M. C. Office for Greenville County in Plat Book WWW, Page 44 and 45, and having according to said plat, the following metes and bounds, to-wit:

BEGINNING At an iron pin on the western side of Lambourn Way, which iron pin is the joint front corner of Lots Nos. 107 and 109 and running thence S. 67-01 W, 158.3 feet to an iron pin; thence S. 19-03 E. 150.0 feet to an iron pin; thence N. 66-45 E, 151.8 feet to an iron pin on the western side of Lambourn Way and running thence along the western side of Lambourn Way N. 16-35 W. 150.0 feet to an iron pin, the point of beginning.
