I, William F. King, of Greenville County,

(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

Sixteen Thousand, Five Hundred and No/100----(\$ 16,500.00) Dollars, as evidenced by Mutgagar's promissory note of even date herewith, said note to be repaid with interest at the rate

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dallars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at any before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagor, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed theyeon situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot #3, Section Five of Richmond Hills, plat of which is recorded in the R. M. C. Office for Greenville County-in Plat Book WWW at Page 38, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southwestern side of Komarock Circle, joint front corner of Lots Nos. 2 and 3, and running thence along the joint line of said lots, S. 2B-34 W. 150.0 feet to an iron pin on the line of property now or formerly of Pearle J. Ross; thence along the line of that property, N. 61-26 W. 110.0 feet to an iron pin at the rear corner of Lot No. 4; thence along the line of that lot, N. 32-23 E. 150.6 feet to an iron pin on the southwestern side of Komarock Circle; thence along the southwestern side of Komarock Circle, S. 60-12 E. 11.8 feet to an iron pin; thence continuing along the southwestern side of Komarock Circle, S. 61-26 E. 88.2 feet to the beginning corner; being the same conveyed to me by Williams Builders, Inc. by deed dated August 25, 1969, to be recorded herewith.
