TO ALL WHOM THESE PRESENTS MAY CONCERN: John E. Danner, Jr. and Sammie Jean G.

Danner -----(hereinafter referred to as Mortgagor) SEND(S) GREETING:

WHEREAS, the Mortgagor is well and truly indebted unto CAROLINA FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, Greenville, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Twenty-three Thousand Three Hundred Fifty and No/100 -----

DOLLARS (\$23,350.00 -----), with interest thereon as provided in said promissory note, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

WHEREAS, the unpaid balance of said debt or debts, if not sooner paid, shall be due and payable, September 1, 1994 -----

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being on the eastern side of Richbourg Road near the City of Greenville, in the County of Greenville, State of South Carolina and known and designated as a portion of Lot No. 6 of a subdivision known as Section 2, Heritage Hill, plat of which is recorded in the R.M.C. Office for Greenville County in Plat Book WWW at Page 15 and according to a more recent survey of the property of W. N. Leslie, Inc. recorded in the R.M.C. Office for Greenville County in Plat Book 4B at Page 89, has the following metes and bounds, to-wit:

BEGINNING at an iron pin on the eastern side of Richbourg Road, which iron pin is 76.1 feet southeast from the intersection of said road and Andover Road and running thence N. 68-47 E., 135 feet to an iron pin in the line of Lot No. 4; running thence S. 22-54 E., 89.6 feet to an iron pin; running thence along a new line through Lot No. 6, S. 67-10 W., 135.6 feet to an iron pin on the eastern side of Richbourg Road; running thence with the eastern side of said road N. 22-50 W., 92.6 feet to an iron pin, point of beginning.
