C., its successors and assigns:

That certain lot, parcel or tract of land, with all improvements now constructed thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, O'Neal Township, about two miles west of O'Neal, being bounded on the northwest and northeast by lands formerly of Albert W. Neves Estate, on the southeast by a community Road and lands of Earnest Neves, and on the southwest by the Groce Meadow Road, and lands formerly of the J. J. Willis Estate, and being the same lot of land conveyed to Toye H. Powell by deed from Jack W. Snipes March 25th, 1948, recorded in the office of the R. M. C. for Greenville County in Deed Book 341 at page 27, and having the following courses and distances to wit:-
