One hundred thirty-one and 21/100------(§ 131.21) Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable 23, years after date; and

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northwestern side of Evergreen Circle and being known and designated as Lot No. 6 on plat of Lakewood recorded in the R. M. C. Office for Greenville County in Plat Book "BBB" at page 181, and having, according to said plat, the following metes and bounds, to-wit:
