"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, designated as Lot No. 10, Section 1, of Oak Crest Subdivision, as shown on plat thereof recorded in Plat Book GG, pages 130-131, of the R.M.C. Office for Greenville County, South Carolina, said let haveing a frontage of 70 feet on the South side of Welcome Avenue, a depth of 150 feet and a rear width of 70 feet; this being the identical property conveyed to/EddM L. Gunter and Carolyn F. Gunter by C. E. Duncan by deed of even date to be recorded.
