"All that certain piece, pacel or lot of land, with all improvements thereon, or hereafter constructed thereon, sinute, lying and being in the State of South Carolina, County of Greenville, Chick Springs Township, located near the corporate limits of the City of Green and west therefrom, being shown and designated as Lot No. 84 on a plat of subdivision known as KING ACRES, made by John A. Simmons, Surveyor, dated August 10, 1963, recorded in the R. M. C. Office for Greenville County in Plat Book YY, at Page 153, and having the following courses and distances:
