with interest thereon from date at the rate of ber centum per annum, to be computed and paid monthly, as stated above, until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereaf, who may sue thereon and foreclose this mortgage; and in case said note should be placed in the hands of an attorney for suit or collection the Mortgagor(s) agree(s) to pay all costs and expenses including a reasonable amount as attorneys fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN. That the said Mortgagor(s), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagen(s) paid by the said Mortgage at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and released, and by these Presents do grant, bargain, sell and release unto the said Mortgagere,

All these certain piaces, parcels, or lets of land, situate, lying and being in Greenville County, whick Springs Township, approximately three (3) miles west of Green, and being shown as lets Mes. 1 and 2 on plat of property of Addie B. Wingo, said plat dated Sentember 27, 1958, by M. S. Brockman, Registered Surveyor, said plat to be recorded herewith, and being shown and described according to said plat as follows:

Baginning at iron pin northwestern corner of Lot No. 1, as shown on said plat, h5 feet south of northbound land of U. S. Superhichway No. 29, and running U. 68-00 E. 85 feet to iron pin along right-of-way line, and thence continuing an additional 85 feet to iron pin corner of Lots Nos. 2 and 3; thence S. 29-00 E. 299-1 feet along joint line of Lots 2 and 3 to iron pin; thence along line, now or fromarly of Larry W. and Ella Mae Long, S. 82-23 W. 80 feet to iron pin; thence continuing S. 82-23 W. 124.7 feet to iron pin; thence ". 36-40 W. 20.8 feet to iron pin; thence along line now or formerly of Sloan, W. 22-52 W. 226 feet to the beginning point. Beforence being made to said plat for a more particular description.

ALSO Grantor hereby grants an easement for the use of water from the well located on other property of grantor and the use of septic tank located on other property of grantor, it being understood that grantse is to bear a proportionate part of the upkeep of said well and septic tank, inleading power for pump, so long as grantor uses said facilities. Was of said facilities to be limited to one dwelling.
