NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagoe at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the scaling and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, barganed, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in the City of Greenville on the Southwest side of East Prentiss Avenue, formerly called Prentiss Avenue, and being known and designated as Lot No. 17, Block "D" Cagle Park as shown on plat thereof made by R. E. Dalton, Engineer, June 1915, recorded in the RMC Office for Greenville County, South Carolina in Plat Book C, Page 238, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the Southwest side of East Prentiss Avenue at the corner of Lot No. 16, and running thence with line of Lot No. 16, S. 33-10 W. 158.4 feet to an iron pin on fifteen-foot (15) alley; thence with said alley, N. 56-28 W. 90 feet; thence still with said alley along a curved line approximately N. 62-18 W. 41 feet to an iron pin, corner of Lot No. 18; thence with line of Lot No. 18; N. 33-30 E. 150.1 feet on iron pin on East Prentiss Avenue; thence with said Avenue, S. 68-40 E. 8.7 feet to an iron pin; thence still with said Avenue, S. 68-19 E. 51.3 feet to the beginning corner.
