MORTGAGE OF REAL ESTATE

TO ALL WHOM THESE PRESENTS MAY CONCERN:

WHEREAS, WE, HAROLD JAMES SMITH, ROBERT REEVES AND JAMES HAROLD SMITH,
(Unmarried),
(hereinafter referred to as Mortgagor) is well and truly indebted unto JOHN W. NORWOOD, JR.

(hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of
THREE THOUSAND AND NO/100----- Dollars (\$3,000.00) due and payable

on or before three (3) years from date, with principal payment of \$1,000.00 due one year from date and a like amount each year thereafter until paid in full,

with interest thereon from date at the rate of 8 per centum per annum, to be paid: annually.

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purposes:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof, and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, having the following metes and bounds:

BEGINNING at a stone corner of Mrs. Addie Crymes and S. G. Walker line, thence S. 9 E. 28.73 chains to stake on bank of Grove Creek; thence N. 54 E. along bank of Grove Creek 6.90 chains to corner of Mrs. Rendie Shular line; thence along her line N. 9 W. 24.53 chains to a stake in the center of a dirt road leading to Pelzer; thence S. 46½ W. 2.38 chains to angle in road; thence N. 88 W. 2.50 chains to angle in road; thence N. 59½ W. 3.00 chains to the beginning corner, containing eighteen and one-tenth (18.1) acres, more or less, being known as Tract #4 of Josephine Walker's lands."
