with interest thereon from date at the rate of eight per centum per annum, to be computed and paid monthly, as stated above, until paid in full; all interest not paid when due to bear interest at the same rate as principal; and if any portion of principal or interest be at any time past due and unpaid, the whole amount evidenced by said note to become immediately due, at the option of the holder hereof, who may sue thereon and foreclose this mortgage; and in case said note should be placed in the hands of an attorney for suit or collection the Mortgageor(s) agree(s) to pay all costs and expenses including a reasonable amount as attorneys' fees, this to be added to the mortgage indebtedness, and to be secured under this mortgage as a part of said debt.

NOW KNOW ALL MEN, That the said Mortgagor(3), in consideration of the said debt and sum of money aforesaid, and for the better securing the payment thereof to the said Mortgagee according to the terms of the said note, and also in consideration of the further sum of Three Dollars to the said Mortgagor(3) paid by the said Mortgagee at and before the signing of these Presents, the receipt whereof is hereby acknowledged, have granted, bargained, sold and release, and by these Presents do grant, bargain, sell and release unto the said Mortgagee,

All that piece, parcel or lot of land in O'Neal Township, Greenvila County, State of South Carolina, containing one and one fourth(14) acres, by estimation, more or less, lying on the north side of road leading from T. E. Morgan's residence to a road connecting O'Neal and the Greer-Landrum Highway, bounded on north and west by O. B. Stokes, east by T. E. Morgan and South by A. Beachum, and having the following courses and distances, to-wit:

BEGINNING at an iron pin at the center of said private road leading from T. E. Morgan's residence to the other said road, and running along the line of T. E. Morgan N.4-18 E. to a maple; thence along the line of L. B. Stokes S. 50-40 W. (gulley in line) to the center of said road in an easterly direction toward the T. E. Morgan residence to the beginning corner.
