NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgage to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.90) to the Mortgagor in hand well and truly paid by the Mortgage at and before the sealing of these presents, the receipt whereof is hereby acknowledged, has graned, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgageo, its successors and assigns, the following described real estate:

All that certain plece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot 28 of a subdivision known as Farmington Acres according to a plat thereof prepared by Carolina Engineering & Surveying Co., dated December 1962 and recorded in the R. M. C. Office for Greenville County in Plat Book RR at Pages 106 and 107 and having, according to said plat, the following metes and bounds, to-wit:

"BEGINNING at an iron pin on the eastern edge of Claxton Drive, joint front corner of Lots 28 and 29 and running thence with the joint line of said lots, N. 57-14 E. 184 feet to an iron pin on the edge of the bank of a creek; running thence with the creek as the line, the traverse line of which is S. 28-50 E. 259.7 feet, to an iron pin at the joint re ar corner of Lots 28 and 27; running thence with the joint line of said lots, S. 77-09 E. 269.5 feet to an iron pin on the eastern side of Claxton Drive, joint front corner of Lots 27 and 28; running thence with the curvature of Claxton Drive, the chord of which is N. 4-32 W. 47.1 feet to an iron pin; thence continuing with the eastern side of Claxton Drive, N. 32-46 W. 25 feet to the point of beginning;
