And the said mortgagor(s) agree(s) to insure and keep insured the houses and buildings on said lot in a sum not

successors, heirs or assigns, to enable such parties to repair said building or to erect new buildings in their place, or for any other purpose or object satisfactory to the Mortgagoe(s), without affecting the fien of this mortgage for the full amount secured thereby before such damage by fire or other casualty, or such payment over, took place.

In case of default in the payment of any part of the principal indebtedness, or of any part of the interest, at the time the same becomes due, or in the case of failure to keep insured for the benefit of the mortgages(s) the houses and buildings on the premises against life and other casualty, as herein provided, or in case of failure to pay any taxes or assessments to become due on aid property within the time required by law in either of said cases the mortgages(s) shall be entitled to declare the entire debt due and to institute foreclosure proceedings.
