WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagoe on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgage at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgage at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

'All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, containing 8.63 acres, on the Southwest side of the road from Greenville to Fork Shoals, commonly known as the Fork Shoals Road, and more particularly described according to a plat by W. J. Riddle, Surveyor, dated December 12, 1951, as follows:

BEGINNING at an iron pin on the Southwest side of the Fork Shoals Road, at or near the intersection of said Road with a County Road, and running thence S. 16 E. 73.9 feet to an iron pin; thence with line of property now or formerly owned by Henry Sullivan, S. 26-30 W. 1038 feet to a stone; thence S. 86-30 E. 306 feet to a stone; thence N. 54-18 E. 632.5 feet to center of said Fork Shoals Road; thence with center of said road, N. 28-29 W. 763 feet to point in center of said road; thence S. 27-00 W. 20.8 feet to the beginning corner.

Being the same premises conveyed to the mortgagor by deed recorded in Volume 461 at Page 153.

Together with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, and all of the rents, issues, and profits which may arise or be had therefrom, and including all heating, plumbing, and lighting fixtures and any other equipment or fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.
