NOW, KNOW ALL MEN, That the Morigagor, in consideration of the aforessid debt, and in order to secure the payment thereof, and of any other and further sums for which the Morigagor may be indubted to the Morigagor any time for advances made to or for his account by the Morigagor and also in consideration of the further sum of Three Dollars (3.0.0) to the Morigagor in hand well and truly paid by the Morigagoe at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Morigagoe, its successors and assions:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 188 as shown on a plat of "WESTCLIFF SUBDIVISION", and Revised Plat of Lots Nos. 189 and 188 prepared by Carolina Engineering & Surveying Co. dated January 13, 1969 and recorded in the RMC Office for Greenville County in Plat Book 4A at Page 75, reference to said plat being craved for a more particular description.

Together with all and singular rights, members, herditaments, and appurtenances to the same belonging in any way incident or epertaining, and of all the rents, issues, and profils which may arise or be had thereform, and including all heating, plumbing, and lighting fixtures now or hereafter attached, connected, or fitted thereto in any manner; it being the intention of the parties hereto that all such fixtures and equipment, other than the usual household furniture, be considered a part of the real estate.

TO HAVE AND TO HOLD, all and singular the said premises unto the Mortgagee, its heirs, successors and assigns, forever.

The Mortgagor covenants that it is leaffully seized of the premises hereinabove described in fee simple absolute, that it has good right and is lawfully authorized to sell, convey or encumbe the same, and that the premises are free and clear of all liens and encumbrances except as provided herein.
