Jenkins, Jr. Fidelity Federal Savings & Loan Assn. of a loan by THE FEDERAL LAND BANK OF GREENVILLE, hereinafter called Bank hereby postpones and subordinates the lien(s) of its mortgage(s) and all of its rights, powers and privileges thereunder, hereinafter collectively called Association
