WHEREAS, the Mortgagor is well and truly indebted unto FIDELITY FEDERAL SAVINGS AND LOAN ASSOCIATION, GREENVILLE, S. C., (hereinafter referred to as Mortgagee) in the sum of

Fifteen Thousand and no/100-----DOLLARS  
(\$15,000.00), with interest thereon at the rate of ~~percent~~ per annum as evidenced by the Mortgagor's note of even date herewith payable as therein stated, or as hereafter modified by mutual agreement, in writing, the final maturity of which is 20 years after the date hereof, unless extended by mutual consent, the terms of said note and any agreement modifying it are incorporated herein by reference; and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced or readvanced to or for the Mortgagor's account, including advances made by the Mortgagee on other or no security:

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, on the northeastern side of Sylvan Way in the City of Greenville, County of Greenville, State of South Carolina, being known and designated as Lots Nos. 98, 99 and 100 as shown on a plat of Marshall Forest recorded in the R. M. O. Office for Greenville County, South Carolina, in Plat Book H at pages 133 and 134, and having according to said plat the following metes and bounds:

BEGINNING at an iron pin on the northeastern side of Sylvan Way at the joint front corner of Lots Nos. 97 and 98, and running thence with the line of Lot No. 97 N. 45-20 E. 216.8 feet to an iron pin on the southwestern side of a 10 foot strip reserved for utilities, etc.; thence with the southwestern side of said Strip N. 41-40 W. 75 feet to an iron pin at the joint rear corner of Lots Nos. 100 and 101; thence with the line of Lot No. 101 S. 45-20 W. 258 feet to an iron pin on the northeastern side of Sylvan Way; thence with the northeastern side of Sylvan Way S. 60-12 E. 25.9 feet to an iron pin at the joint front corner of Lots Nos. 99 and 100; thence continuing with the northeastern side of Sylvan Way S. 75-57 E. 58.5 feet to the point of beginning;
