on the northern side of Webster Road in the City of Greenville, being shown as Lot 5 on

Plat of the Property of Leslie & Shaw recorded in Plat Book II at page 39, and being the same property conveyed to Chester H. Miller by deed recorded in Deed Book 528 at page 427.

ALSO: All that other piece, parcel or lot of land in Bates Township, Greenville County, South Carolina, containing 6.81 acres, being shown on plat recorded in Plat Book FF at page 227, and having according to said plat the following metes and bounds:
