All that piece, parcel or tract of land located in the County of Greenville, State of South Carolina, bounded on the West and East by land of J. T. Garrison, and on the North by land of Virginia G. Knight, said tract is further shown as a one acre tract on plat prepared by C. O. Riddle, dated February 3, 1966, and designated property of Susie D. Jackson, having the following metes and bounds, to-wit:

BEGINNING at a point in County Road and thence N. 32-44 E. 366.9 feet to iron pin at rear of tract, thence N. 39-15 W. 118.9 feet to iron pin; thence S. 32-44 W. 403.9 feet to an iron pin in said County Road; thence down said road S. 57-24 E. 113 feet to the BEGINNING corner.

Being the same property conveyed to the said party of the first part by deed from J. T. Garrison, recorded in Book 798 at page 52 in the Greenville County Public Registry, to which deed and deeds therein referred to, reference is hereby made.
