- 5. In case the indebtedness secured hereby or any part thereof is collected by sult or action or this mortgage is foreclosed, or put into the handstid of an attorney for collection, sult, action or foreclosure. Mortgager shall be chargeable with all costs and expenses, including reasonable attorney's feet, which shall be immediately due and payable and added to the mortgage indebted. ness and secured hereby.
- 9. No delay by Mortgage in exercising any right or remedy hereunder, or otherwise afforded by law, shall operate as a waiver thereof or preclude the exercise thereof during the continuance of any default hereunder,
