"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Caroline, County of Greenville on the western side of Owens Road, being shown and designated as Lot No. 23 on Plat of Lorena Park, which plat is recorded in the R.M.C.
