MORTGAGE OF REAL ESTATE

COUNTY OF GREENVILLE TO All Whom These Presents May Concern:

I, William F, King, of Greenville County

(hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgagor to the Mortgagor's account, and also in consideration of the sum of Three Dallars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the scaling of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagor, its successors and assigns, the following described real estate:

All that certain piece, parcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, in Paris Mountain Township, being shown as Lot 36 of Section I, of a subdivision of Blue Ridge Realty Co., Inc. known as Fenwick Heights, plat of which is recorded in Plat Book QQ, at Pages 44-45 in the R. M. C. Office for Greenville County, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southeastern side of Fenwick Lane, joint front corner of Lots 35 and 36, and running thence along the joint line of said lots, S. 17-06 E, 182.4 feet to an iron pin; thence S. 72-58 W. 120.0 feet to an iron pin at the rear corner of Lot 37; thence along the line of that lot, N. 17-02 W. 180.0 feet to an iron pin on the southeastern side of Fenwick Lane; thence along the southeastern side of Fenwick Lane, N. 71-48 E. 119.8 feet to the beginning corner; being the same conveyed to me by Bates & Cannon, Inc. by deed dated April 15, 1969 and recorded in the R. M. C. Office for Greenville County in Deed Vol. 866, at Page, 114.
