TOGETHER with all and singular the rights, members, hereditaments, and appurtenances to the same belonging or in any way incident or appertaining, including all heating, plumbing and electrical fixtures, and any other equipment or fixtures now or hereafter attached, connected or ittled in any manner, it being the intention of the parties hereto that all such fixtures and equipment, other than household furniture, be considered a part of the realty.

TO HAVE AND TO HOLD all and singular the said premises unto the Mortgagee, its successors and assigns forever.

The Mortgagor represents and warrants that said Mortgagor is seized of the above described premises in fee simple absolute; that the above described premises are free and clear of all llens or other encumbrances; that the Mortgagor is lawfully empowered to convey or encumber the same; and that the Mortgagor will forever defend the said premise unto the Mortgage, its successors and assigns, from and against the Mortgagor and every person whomsoever lawfully claiming or to claim the same or any part thereof.

The Mortgagor covenants and agrees as follows:

- That the Mortgagor will promptly pay the principal and interest on the indebtedness evidenced by said promissory note at the times and in the manner therein provided.
- 2. That this mortgage will secure the Mortgagee for any additional sums which may be advanced hereafter, at the option of the Mortgagee, for the p-yment of taxes, or public assessments, hazard insurance premiums, repairs or other such purposes pursuant to the provisions of this mortgage, and also for any loans or advances that may hereafte be made by the Mortgagee under the authority of Sec. 45-55, 1902 Code of laws of South Carolina, as amended, or similar statutes; and all sums so advanced shall been interest at the same rate as that provided in said note and shall be payable at the demand of the Mortgagee, unless otherwise provided in writing.
- 3. That Mortgagor will keep the improvements on the mortgaged premises, whether now existing or hereafter to be erected, insured against loss by fire, windstorm and other hazards in a sum not last than the balance due hereander at any time and in a company or companies acceptable to the Mortgagee, and Mortgagor dues hereby assign the policy or policies of insurance to the Mortgagee and agrees that all such policies shall be held by the Mortgage and shall insuite loss payable clauses in favor of the Mortgagee; and in the event of loss Mortgagor will give immediate notice thereof to the Mortgagee by registered mail; and should the Mortgagor at any time fall to keep said premises insured or fall to pay the permisure for such insurance, then the Mortgagee may cause such improvements to be insured in the name of the Mortgagor and reimburse listelf for the cost of such insurance, with interest as hereinabove provided.
- 4. That the Mortgagor will keep all improvements upon the mortgaged premises in good repair, and should Mortgagor fail to do so, the Mortgagee may, at its option, enter upon said premises and make whatever repairs are necessary and charge the expenses for such repairs to the mortgage debt and collect the same under this mortgage, with interest as hereinabove provided.
- 5. That the Mortgagee may at any time require the issuance and maintenance of insurance upon the life of any person obligated under the indebtedness secured hereby in a sum sufficient to pay the mortgage debt, with the Mortgagee as beneficiary, and if the premiums are not otherwise paid, the Mortgagee may pay said premiums and any amount so paid shall become a part of the mortgage debt.
- 6. That Mortgagor agrees to pay all taxes and other public assessments levied against the mortgaged premises on or before the due dates thereof and to exhibit the receipts therefor at the offices of the Mortgage immediately upon payment, and should the Mortgagor fail to put such taxes and assessments when the same shall fall due, the Mortgage may at its option, pay the same and charge the amounts so paid to the mortgage debt and collect the same under this mortgage, with interest is above provided.
- 7. That if this mortgage secures a "construction loan", the Mortgagor agrees that the principal amount of the indebtedness hereby secured shall be disbursed to the Mortgagor in periodic payments, as construction progresses, in accordance with terms and conditions of a Construction Loan Agreement which is separately executed but is made a part of this mortgage and incorporated herein by reference.
- 8. That the Mortgagor will not further encumber the premises above described, nor alienate said premises by way of moltgage or deed of conveyance without the prior consent of the Mortgage, and should the Mortgagor so encumber or alienate such premises, the Mortgagor may at its option, declare the indeteledness hereby secured to be immediately due and payable and may institute any proceedings necessary to collect said indebtedness.

That if the indebtedness secured by this mortgage be guaranteed or insured by mortgage guaranty insurance, the Mortgagor agrees to pay to the Mortgagor of each month until the note secured hereby is fully paid, the following sums in addition to the payments of principal and interest provided in said note: a sum equal to the premiums that will next become due and payable on policies of fire and other hazard insurance covering an engaged property, plus laxes, and assessments next due on the mortgaged premises (all as estimated by the Mortgagee) less all sams already paid therefor, divided by the number of months to elapse before one month prior to the date when such promiums, taxes, and assessments should these payments exceed the amount of payments actually made by the Mortgagee for taxes, assessments, for insurance premiums, the excess may be credited by the Mortgagee on subsequent payments to be made by the Mortgager of taxes, assessments, if, however, said sums shall be insufficient to make said payments where the same shall been due and payable, the Mortgager shall pay to the Mortgage any amounts necessary to make up the deficiency. The Mortgager further agrees that at the old of ten years from the date hereof, Mortgagee may, at its option, payly for renewal of mortgage guaranty or similar insurance covering the balance then remaining due on the mortgage debt, and the Mortgagor may, at its option, payl he single premium required for the remaining years of the term, or the Mortgagee may any such premium and add the same to the mortgage debt, in which event the Mortgagor shall repay to Mortgagee such premium payment period.
