Howard by S. D. Atkins (field) and W. N. Willis, Surveyors, dated April 11, 1969, and having the following metes and bounds, to-wit:

BEGINNING in the center of said road about N. 6-00 E. 800 feet from Fred Moon corner, and running thence with the center of said road the following courses and distances: N. 2-55 E. 148.5 feet, N. 13-18 W. 100 feet and N. 26-55 W. 100 feet to a belt in center of said road; thence leaving said road and running N. 62-45 E. 224 feet (iron pin set off at 33 feet on east side of road) to a stone; thence S. 23-25 E. 321 feet to an iron pin; thence S. 62-30 W. 300 feet (iron pin on east side of road at 40 feet) to the beginning corner, and containing 1.8 acres, more or less.
