And said mortgage agrees to keep the building sod improvements now standing or becenter erocted upon the mortgaged premises and any and all appearants at the posterious how or becenter in a state of the and buildings or improvements, natured against less or damage by fire and such other hexards as the mortgage may from time to time require, all such insurance to be in forms, in companies and in sums not less than sufficient to avoid any date on the part of the insurers for consumnce) satisfactory to the mortgages, that all insurance policies shall be held by and shall be for the benefit of and first payable in case of loss to the mortgages, and that at least fifteen days before the expiration of each such policy, a new and sufficient policy to take the place of the one of expiring shall be delivered to the mortgage. The mortgage hereby assigns to the mortgages all moneys reconverable under each nuch policy, and agrees that in the event of a loss the amount collected under any policy of insurance on said property may, at the option of the mortgages, be applied by the mortgage upon any indebtedness and/or obligation secured hereby and in such order as mortgages may determine; or said amount or any portion thereof may, at the option of the mortgage, either be used in replacing, repairing or restoring the improvements partially or totally destroyed to a condition satisfactory to said mortgages, or be released to the mortgage in either of which events the mortgages shall not be obligated to see to the proper application thereof; nor shall the mortgage attorney irrevocable of the mortgage road such policy in the event of the foreclosure of this mortgage. In the event the mortgage may cause the same to be insured and reimbursts itself for the premium, with interest, under this mortgage, or the mortgage at its election may on such failure declare the debt due and institute foreclosure proceedings.
