MODIFICATION AGREEMENT INCREASING INTEREST RATE

WHEREAS Fidelity Federal Savings and Loan Association of Greenville, South Carolina, is the owner and holder of a promissory note dated July 9, 1965 executed by J. E. In consideration of the premises and the further sum of \$1.00 paid by the Association to the Obligor, receipt of which is hereby acknowledged, the undersigned parties agree as follows:

(1) That the interest rate on the loan balance of \$32,019.49 be increased to $7\frac{1}{2}$ %.

- (2) That the Obligor agrees to repay said obligation in monthly installments of \$243.6 leach, with payments to be applied first to interest and then to the remaining principal balance due from month to month, with the first monthly payments being due <u>December 9</u>
- (3) That all terms and condition as set out in the note and mortgage shall continue in full force, except as modified expressly by
- (4) That this Agreement shall bind jointly and severally the successors and assigns of the Association and Obligor, his heirs, successors and assigns.
