WHEREAS, the Mortgagor is well and truly indebted unto FOUNTAIN INN FEDERAL SAVINGS AND LOAN ASSOCIATION OF Fountain Inn, S. C., (hereinafter referred to as Mortgagee) as evidenced by the Mortgagor's promissory note of even date herewith, the terms of which are incorporated herein by reference, in the sum of Fifteen Thousand and 00/100 - - - - - *** Note

DOLLARS (\$ 15,000.00), with interest thereon from date at the rate of Seven & Nine-Tenths per centum per annum, said principal and interest to be paid as therein stated, and

WHEREAS, the Mortgagor may hereafter become indebted to the said Mortgagee for such further sums as may be advanced to or for the Mortgagor's account for taxes, insurance premiums, public assessments, repairs, or for any other purpose, and

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforesaid debt, and in order to secure the payment thereof and of any other and further sums for which the Mortgagor may be indebted to the Mortgagee at any time for advances made to or for his account by the Mortgagee, and also in consideration of the further sum of Three Dollars, (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagee at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, sold and released, and by these presents does hereby grant, bargain, sell and release unto the Mortgagee, its successors and assigns.

All that piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, Fairview Township, containing 3.3 Acres, in accordance with Plat made for Mary Alice Rumpfelt by Lewis C. Godsey, dated September 13, 1968, and being more fully described in accordance with the said Plat, to-wit:

BEGINNING at a bottle cap in the center of Bryson Drive, being the Western property line of property now or formerly of Mary E. Leake, and also being near the crossing of Duke Power line right-of-way and running thence along the center of said Bryson Drive, N. 59-44 E., 160 ft. to a point; thence N. 63-35 E., 268.5 ft. to a point; thence S. 37-25 E., 279 ft. to an iron pin; thence S. 60-21 W., 457.8 ft. to an iron pin; thence N. 59-39 W., 238.8 ft. to an iron pin; thence N. 24-12 E., 139.6 ft. to bottle cap in center of Bryson Drive, being the point of beginning.
