NOW, KNOW ALL MEN, That the Mortgagor, in consideration of the aforescit debt, and in order to secure the payment thereof, and on other and further sums for which the Mortgagor may be indebted to the Mortgagor any time for advances made to or for his account by the Mortgagor, and also in consideration of the further sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the sealing and delivery of these presents, the receipt whereof is hereby acknowledged, has granted, bargained, solid and released, and by these presents does grant, bargain, sell and release unto the Mortgagor, its successors and assigns:

"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being shown and designated as Let to. 12 of Tillman Count on plat thereof recorded in the Med Office for Greenville County in Plat Book RK At page 155 and having such metes and bounds as shown thereon. Said property containing 1.56 acred more or less.

This mortgage and the note which it secures may not be assumed by any part of parties or subsequent purchasers of the property and in the event this property is said or transferred by contract, deed or otherwise this cortiage that the note which same secures shall become immediately due and payable in tail.
