All that piece, parcel or lot of land, situate, lying and being near the City of Greenville, in the County of Greenville, State of South Carolina, being known and designated as Lot No. 27 in a subdivision for Elizabeth E. Voyles, plat of which is recorded in the RMC Office for Greenville County, South Carolina, in Plat Book Y, page 73, said property being located on the Southerly side of Echols Drive.
