"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate bying and being in the State of South Carolina, County of Greenville, O'Neal Township, containing 5.05 acres, more or less, situated on the west side of the Groce Meadow Road about one-half mile westward from the Milford Baptist Church, and having the following courses and distances, to-wit:

BEGINNING at a point in the Groce Meadow Road, corner of Homer Harbin lot and the lot herein, and running thence along the said road, N. 9-30 W. 475 feet to the corner of a lot now or formerly belonging to B. C. Campbell; thence along the Campbell line, S. 80-45 W. 525 feet to a pin on the Arledge line; thence with the Arledge line, S. 14-45 E. 392.5 feet to an iron pin, corner of the Harbin lot; thence with the Harbin line, S. 89-15 E. 495 feet to the beginning corner.
