MORTGAGE OF REAL ESTATE

To All Whom These Presents May Concern:

We, Harold B. Crowson, Jr. and Charlotte P. Crowson, of Greenville County,

... (hereinafter referred to as Mortgagor) SEND(S) GREETINGS:

WHEREAS, the Mortgagor is well and truly indebted unto FIRST FEDERAL SAVINGS AND LOAN ASSOCIATION OF GREENVILLE, SOUTH CAROLINA (hereinafter referred to as Mortgagee) in the full and just sum of

Sixteen Thousand, Seven Hundred Fifty and No/100----- (s. 16,750.00), Dolhars, as evidenced by Mortgagor's promissary note of even date herewith, said note to be repaid with interest at the rate

therein specified in installments of One Hundred Twenty-Nine and 29/100---- (\$ 129,29)
Dollars each on the first day of each month hereafter, in advance, until the principal sum with interest has been paid in full, such payments to be applied first to the payment of interest, computed monthly on unpaid principal balances, and then to the payment of principal with the last payment, if not sooner paid, to be due and payable. 29 years after date; and

WHEREAS, said note further provides that if at any time any portion of the principal or interest due thereunder shall be or the Charter of the Mortgage, or any stipulations set out in this mortgage, the whole amount due thereunder shall, at the option of the holder thereof become immediately due and payable, and said holder shall have the right to institute any proceedings upon said note and any collaterals given to secure same, for the purpose of collecting said principal due, and interest, with costs and expenses for such proceedings; and

WHEREAS, the Mortgagor may hereafter become indebted to the Mortgagor or such further sums as may be advanced to the Mortgagor's account for the payment of taxes, insurance premiums, repairs, or for any other purpose;

NOW, KNOW ALL MEN, That the Mortgagor, in consideration of said debt and to secure the payment thereof and any further sums which may be advanced by the Mortgage to the Mortgagor's account, and also in consideration of the sum of Three Dollars (\$3.00) to the Mortgagor in hand well and truly paid by the Mortgagor at and before the sealing of these presents, the receipt whereof is livereby acknowledged, has granted, bargained, sold, and released, and by these presents does grant, bargain, sell and release unto the Mortgagoe, its successors and assigns, the following described real estate:

All that certain piece, purcel, or lot of land, with all improvements thereon, or hereafter to be constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, being known and designated as Lot No. 271, as shown on a plat of the subdivision of Colonial Hills, Section 6, recorded in the R. M. C. Office for Greenville County in Plat Book WWW, at Pages 12

THE MORTGAGOR'S PROMISSORY NOTE REFERRED TO ABOVE, CONTAINS, AMONG OTHER THINGS, A PROVISION FOR AN INCREASE IN THE INTEREST RATE. and 13, and having, according to said plat, the following metes and bounds, to-wit:

BEGINNING at an iron pin on the southern side of Creighton Street, joint front corner of Lots 271 and 272, and running thence with the joint line of said lots, S. 16-25 E. 243.7 feet to an iron pin; thence continuing with said line to the center of a creek; thence with the center of a creek as the property line, the chord of which is S. 59-08 W. 104.9 feet, to an iron pin, joint rear corner of Lots 270 and 271; thence leaving the center of said creek, N. 16-05 W. to an iron pin on the bank of said creek; thence continuing N. 16-05 W. 269.7 feet to an iron pin on the southern side of Creighton Street; thence with Creighton Street, N. 73-25 E. 100 feet to the beginning corner; being the same conveyed to us by J. P. Medlock by deed of even date, to be recorded herewith.
