"ALL that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of GREENVILLE, all those two (2) lots or tracts of land lying on the southern side of an unnamed road leading to Woodruff Road, Highway 146, and shown as Tracts 1 and 2 on a plat of property of W. R. Cox and Mrs. N. L. Cox by C. F. Webb, dated April 12, 1969, and having, according to said plat, the following metes and bounds, to-wit:
