"All that certain piece, parcel or lot of land, with all improvements thereon, or hereafter constructed thereon, situate, lying and being in the State of South Carolina, County of Greenville, Paris Mountain

Township, situate on the north side of North Parker Road, being shown as Lot 2 on plat prepared by C. C. Jones, C. E., dated December 18, 1962, and having according to said plat the following metes and bounds:

Beginning at an iron pin on the northern side of North Parker Road at the joint front corner of Lots 1 and 2, which pin is 274.5 feet along North Parker Road from the intersection of North Parker Road and Honeysuckle Drive; thence along the joint line of Lots 1 and 2, N 28-42 E 168.1 feet to an iron pin; thence S86-21 E 107.2 feet to an iron pin at rear corner of Lot 3; thence along line of Lot 3, S 30-45 W 227 feet to an iron pin on the northern side of North Parker Road; thence along the northern side of North Parker Road, N 53-00 W 90 feet to the beginning corner.
