MODIFICATION AGREEMENT INCREASING INTEREST RATE

(2) That the Obligor agrees to repay said obligation in monthly installments of \$263.00 each, with payments to be applied first to interest and then to the remaining principal balance due from month to month, with the first monthly payments being due January 1

(3) That all terms and condition as set out in the note and mortgage shall continue in full force, except as modified expressly by this Agreement.
